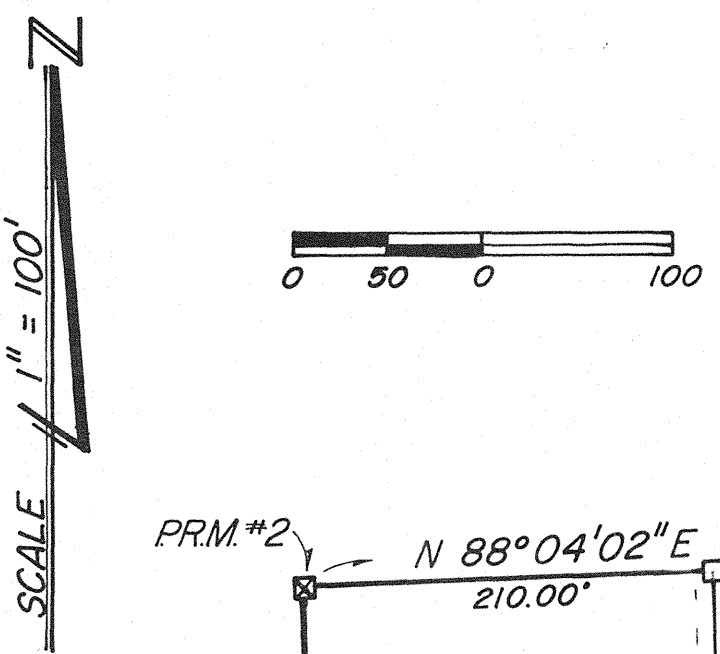


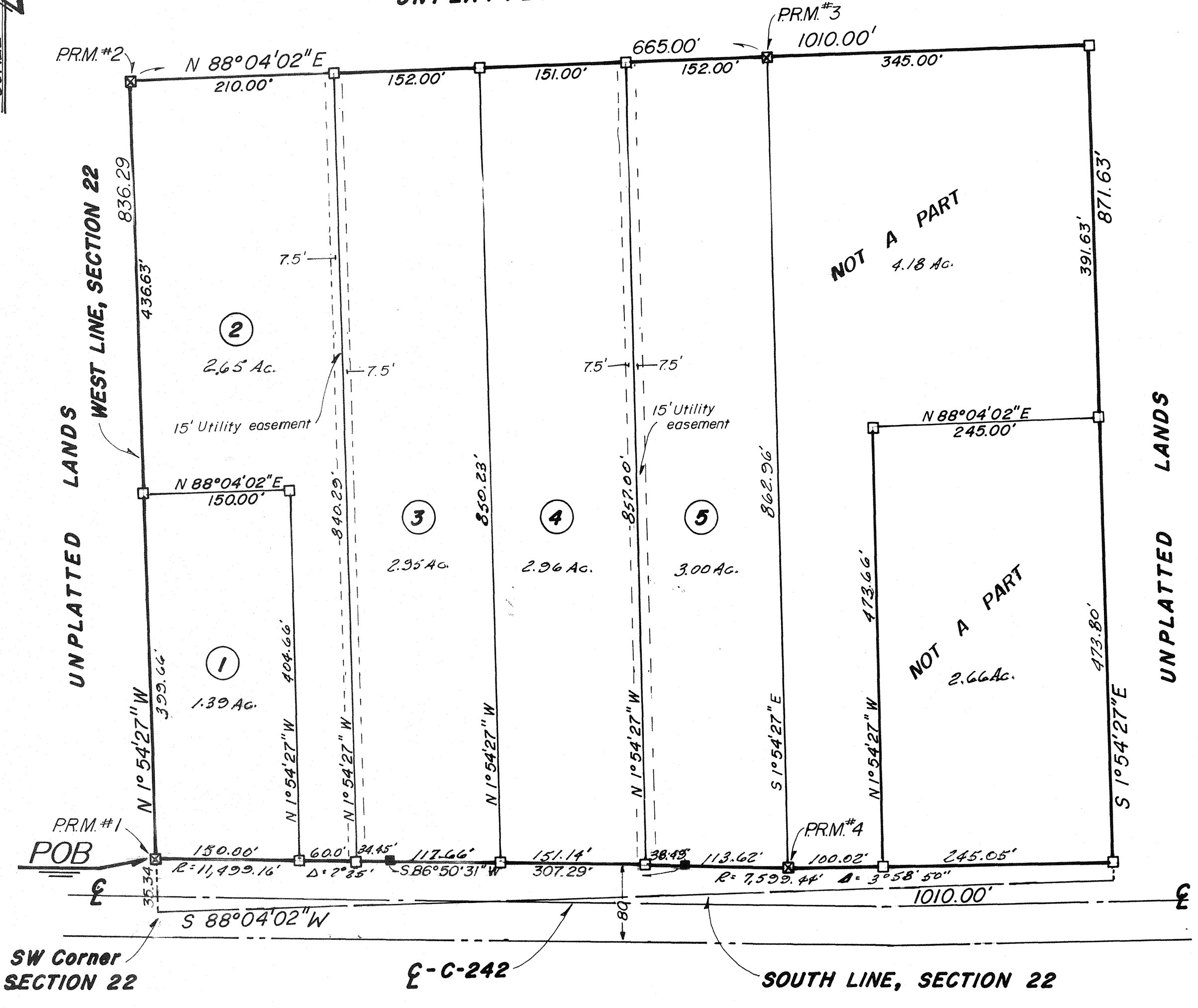

DESCRIPTION

Commence at the SW Corner, Section 22, Township 4 South, Range 16 East, thence run N 1° 54' 27" W, along the West line of Section 22, a distance of 35.34 feet to the North right-of-way of C-242 and the POINT OF BEGINNING, thence continue N 1° 54' 27" W, along said West line, 836.29 feet, thence N 88° 04' 02" E, 665.00 feet, thence S 1° 54' 27" E, 862.96 feet to the North right-of-way of C-242, said point being on a curve concave to the North having a total central angle of 3° 58' 50" and a radius of 7,599.44 feet, thence West, along said curve, an arc distance of 113.62 feet to the point of tangency of said curve, thence S 86° 50' 31" W, 307.29 feet to the point of curvature of a curve concave to the South having a total central angle of 11,499.16 feet, thence West, along said curve, an arc distance of 244.45 feet to the POINT OF BEGINNING.
