

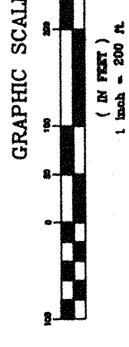
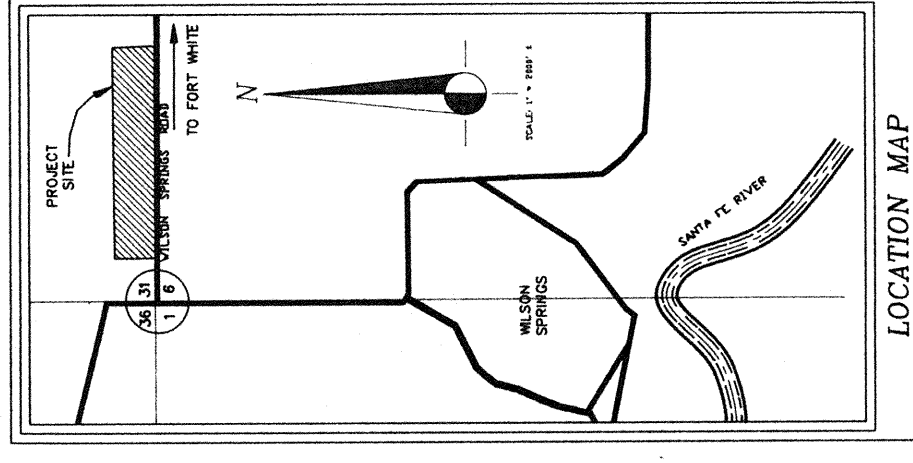

COLUMBIA COUNTY, FLORIDA.

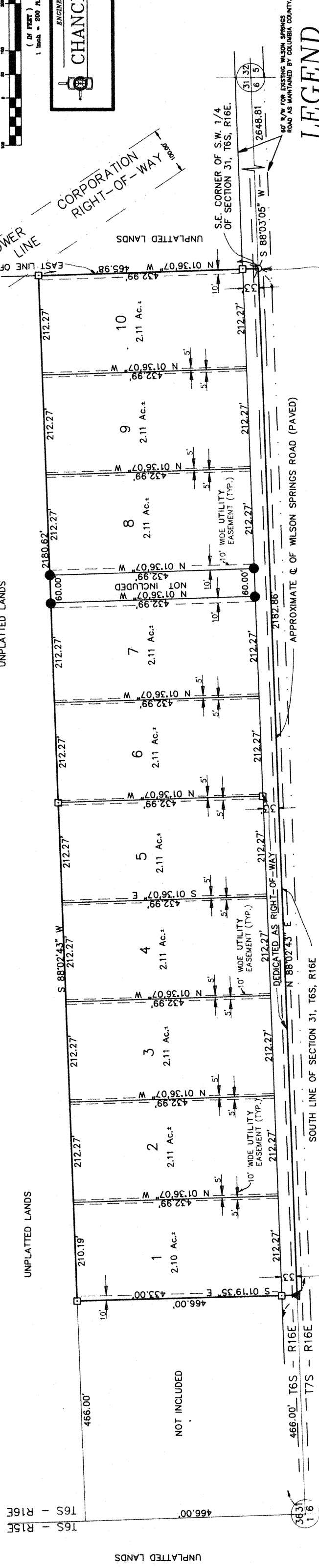

Begin at the southeast corner of said southwest 1/4 and run thence North 01°36'07" West, along the east line of said southwest 1/4, 465.98 feet to a concrete monument; thence South 88°02'43" West, parallel to the south boundary of said section 2180.62 feet; thence South 01°19'35" East, 466.00 feet to said south boundary of southwest 1/4; thence North 88°02'43" East, along said south boundary 2182.86 feet to the POINT OF BEGINNING.

Containing 23.34 Acres, more or less, including that part lying within the right-of-way of Wilson Springs Road.
