STREET, 2055 FEET FOR A POINT OF BEGINNING
AND RUN THENCE SOUTH $88^{\circ}58'$ EAST 298.00
FEET, THENCE SOUTH $1^{\circ}05'$ WEST 294.80 FEET,
THENCE NORTH $88^{\circ}58'$ WEST 298.00 FEET TO
SAID ERMINE STREET, THENCE NORTH $70^{\circ}5'$
EAST 294.80 FEET TO POINT OF BEGINNING.

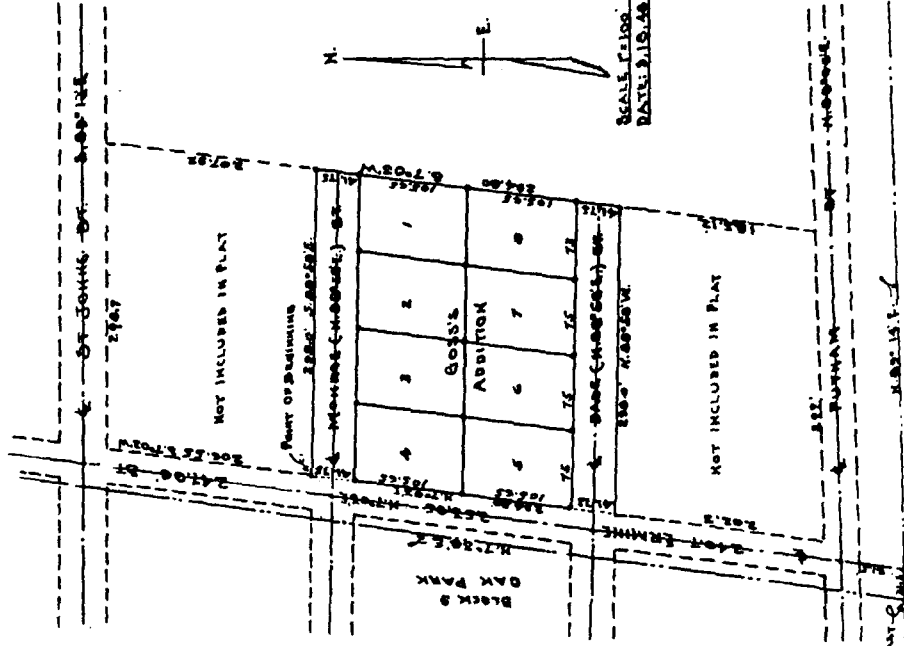
