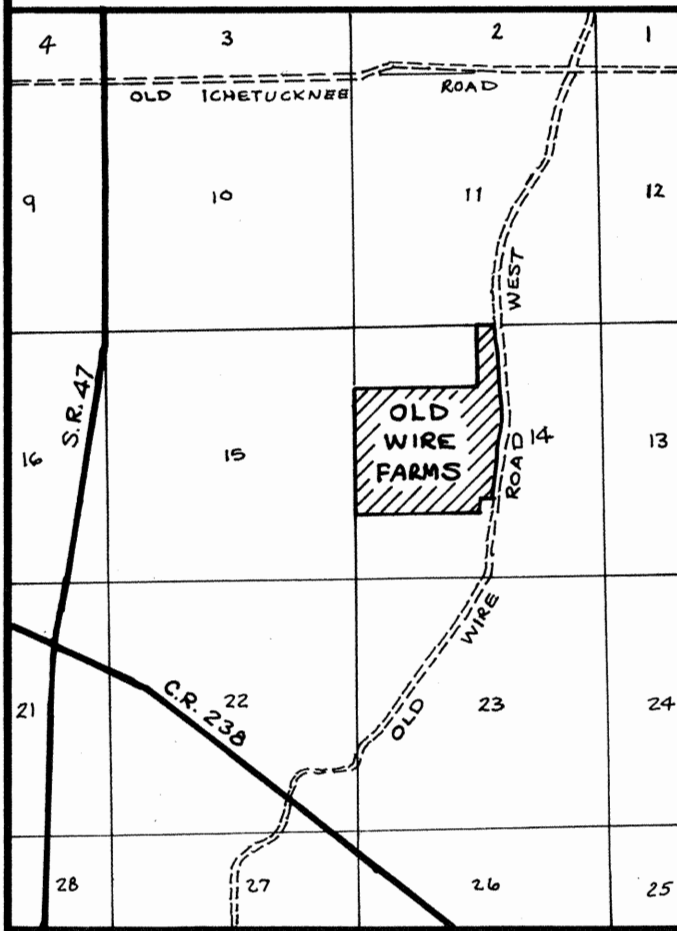


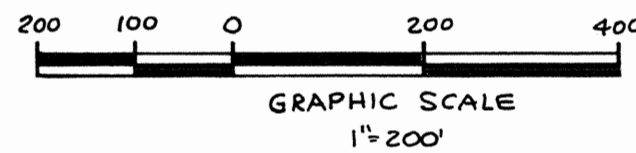

LOCATION MAP



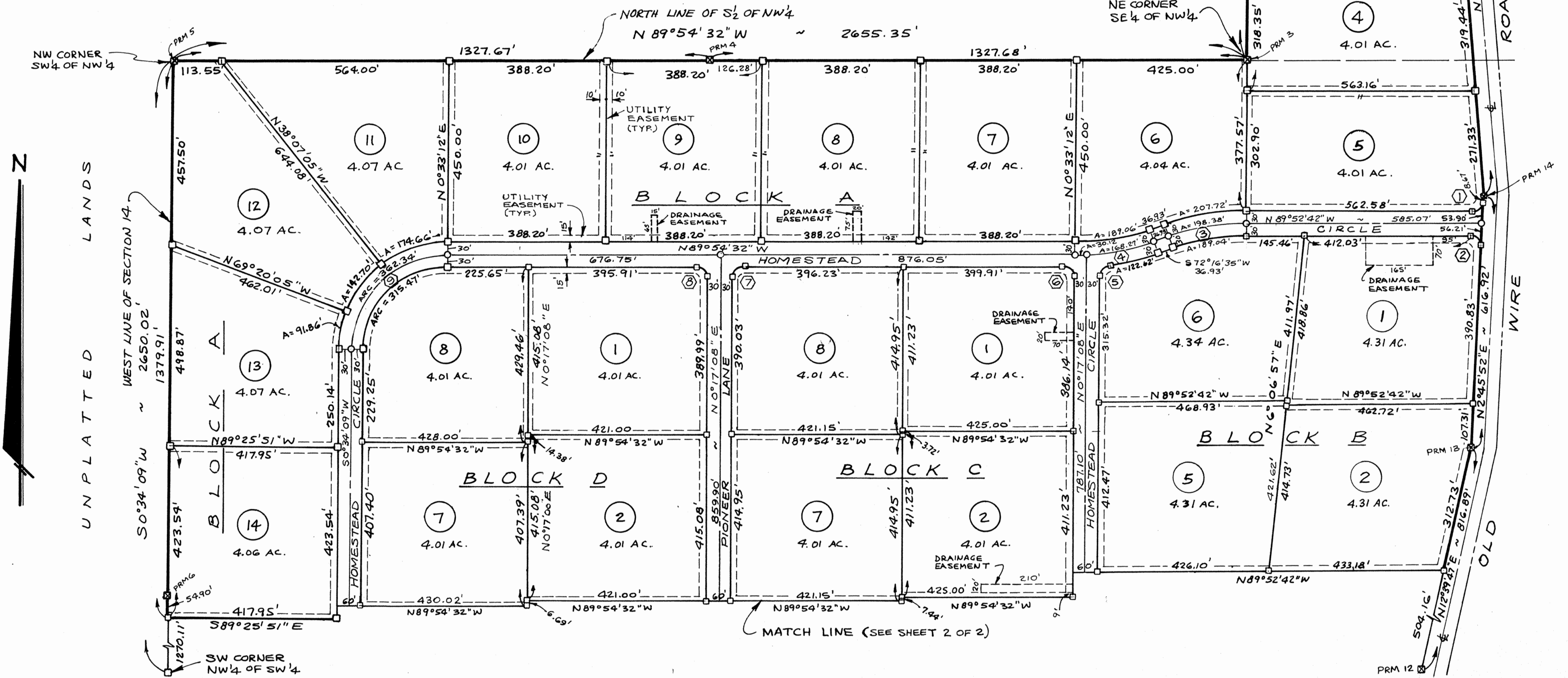
DESCRIPTION

BEGIN AT THE NORTHEAST CORNER OF THE NW $\frac{1}{4}$, SECTION 14, TOWNSHIP 6 SOUTH, RANGE 16 EAST, COLUMBIA COUNTY, FLORIDA AND RUN THENCE S 0° 33' 12" W ALONG THE EAST LINE OF SAID NW $\frac{1}{4}$, 1323.59 FEET TO THE NORTHEAST CORNER OF THE SE $\frac{1}{4}$ OF NW $\frac{1}{4}$, THENCE N 89° 54' 32" W ALONG THE NORTH LINE OF THE S $\frac{1}{2}$ OF SAID NW $\frac{1}{4}$, 2655.35 FEET TO THE NORTHWEST CORNER OF THE SW $\frac{1}{4}$ OF NW $\frac{1}{4}$, THENCE S 0° 34' 09" W ALONG THE WEST LINE OF SAID SECTION 14, 2650.02 FEET TO THE SOUTHWEST CORNER OF THE NW $\frac{1}{4}$ OF SW $\frac{1}{4}$, THENCE S 89° 58' 55" E ALONG THE SOUTH LINE OF THE N $\frac{1}{2}$ OF SAID SW $\frac{1}{4}$, 2656.11 FEET TO THE SOUTHWEST CORNER OF THE NE $\frac{1}{4}$ OF SW $\frac{1}{4}$, THENCE N 0° 33' 12" E ALONG THE EAST LINE OF SAID SW $\frac{1}{4}$, 290.00 FEET, THENCE S 89° 58' 55" E, 304.95 FEET TO THE WEST RIGHT-OF-WAY LINE OF OLD WIRE ROAD WEST, THENCE N 8° 53' 10" E ALONG SAID WEST RIGHT-OF-WAY LINE, 604.36 FEET, THENCE N 12° 39' 47" E ALONG SAID WEST RIGHT-OF-WAY LINE, 816.89 FEET, THENCE N 2° 45' 52" E ALONG SAID WEST RIGHT-OF-WAY LINE, 616.92 FEET, THENCE N 4° 38' 05" W ALONG SAID WEST RIGHT-OF-WAY LINE, 1674.37 FEET TO THE NORTH LINE OF SAID SECTION 14, THENCE N 89° 52' 42" W ALONG SAID NORTH LINE, 436.29 FEET TO THE POINT OF BEGINNING. 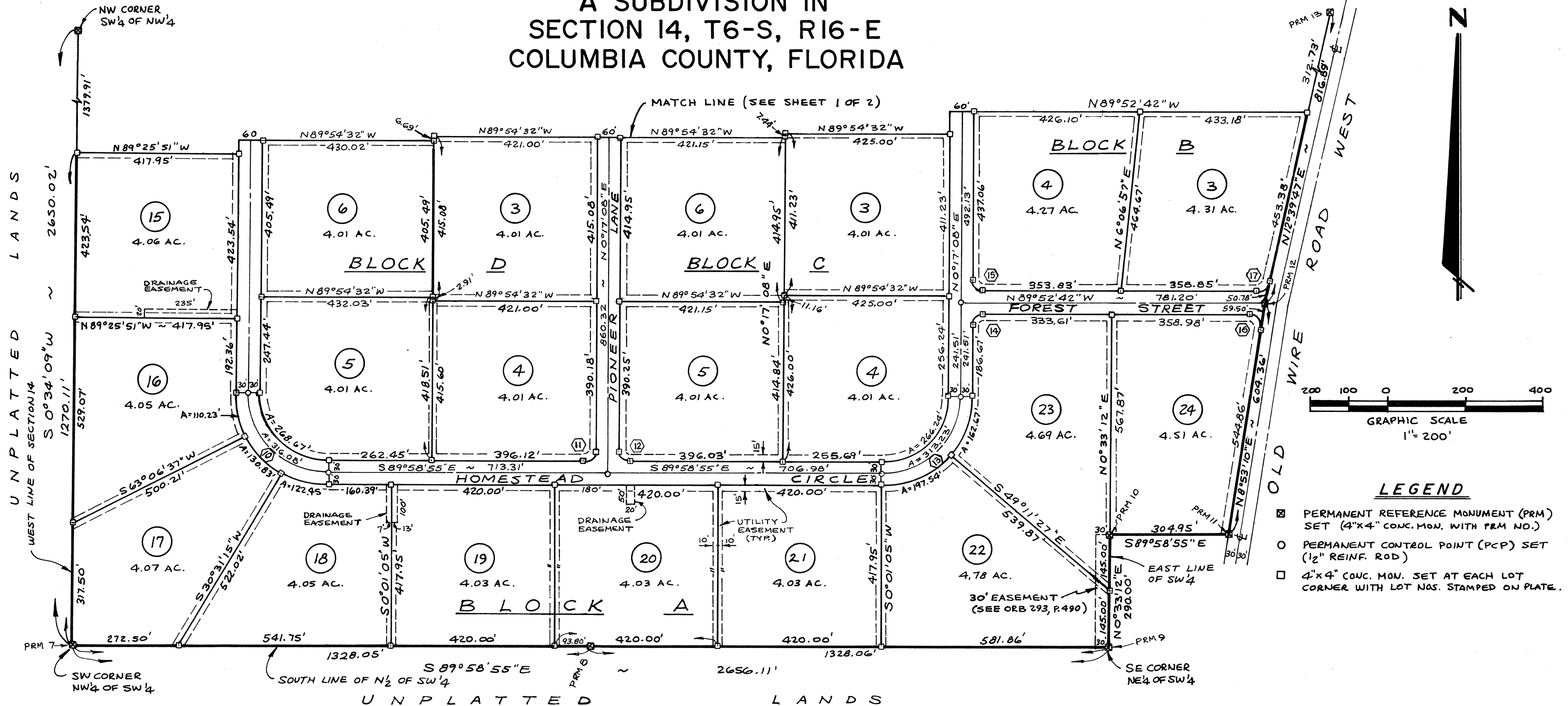
