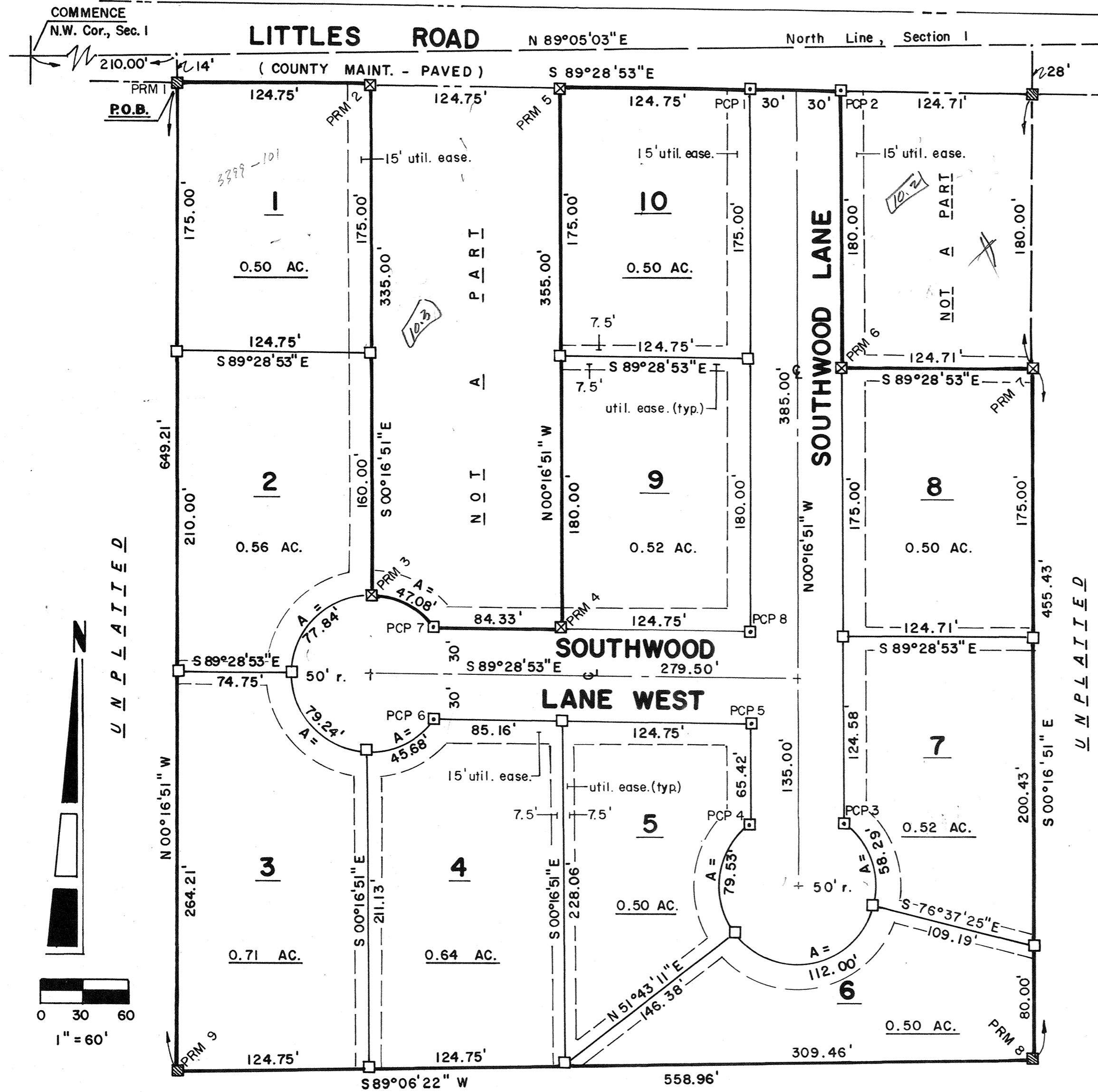


"SOUTHWOOD VILLAGE"

A SUBDIVISION IN
SECTION 1, TOWNSHIP 5 SOUTH, RANGE 16 EAST
COLUMBIA COUNTY, FLORIDA



DESCRIPTION

COMMENCE at the Northwest corner of Section 1, Township 5 South, Range 16 East, Columbia County, Florida and run N.89°05'03"E. along the North line of Section 1 a distance of 210.00 feet; thence S.00°16'51"E. 14.00 feet to the POINT OF BEGINNING; thence S. 89°28'53"E. along the South maintained R/W line of Littles Road 124.75 feet; thence S.00°16'51"E. 335.00 feet to a point on a curve concave to the South having a radius of 50.00 feet and a central angle of 53°55'43"; thence Easterly along said curve 47.08 feet; thence S.89°28'53"E. 84.33 feet; thence N.00°16'51"W. 335.00 feet to the South line of said Littles Road; thence S.89°28'53"E. 184.75 feet; thence S.89°28'53"E. 124.71 feet; thence S.00°16'51"E. 455.43 feet; thence S.89°06'22"W. 558.96 feet; thence N.00°16'51"W. 649.21 feet to the POINT OF BEGINNING.
