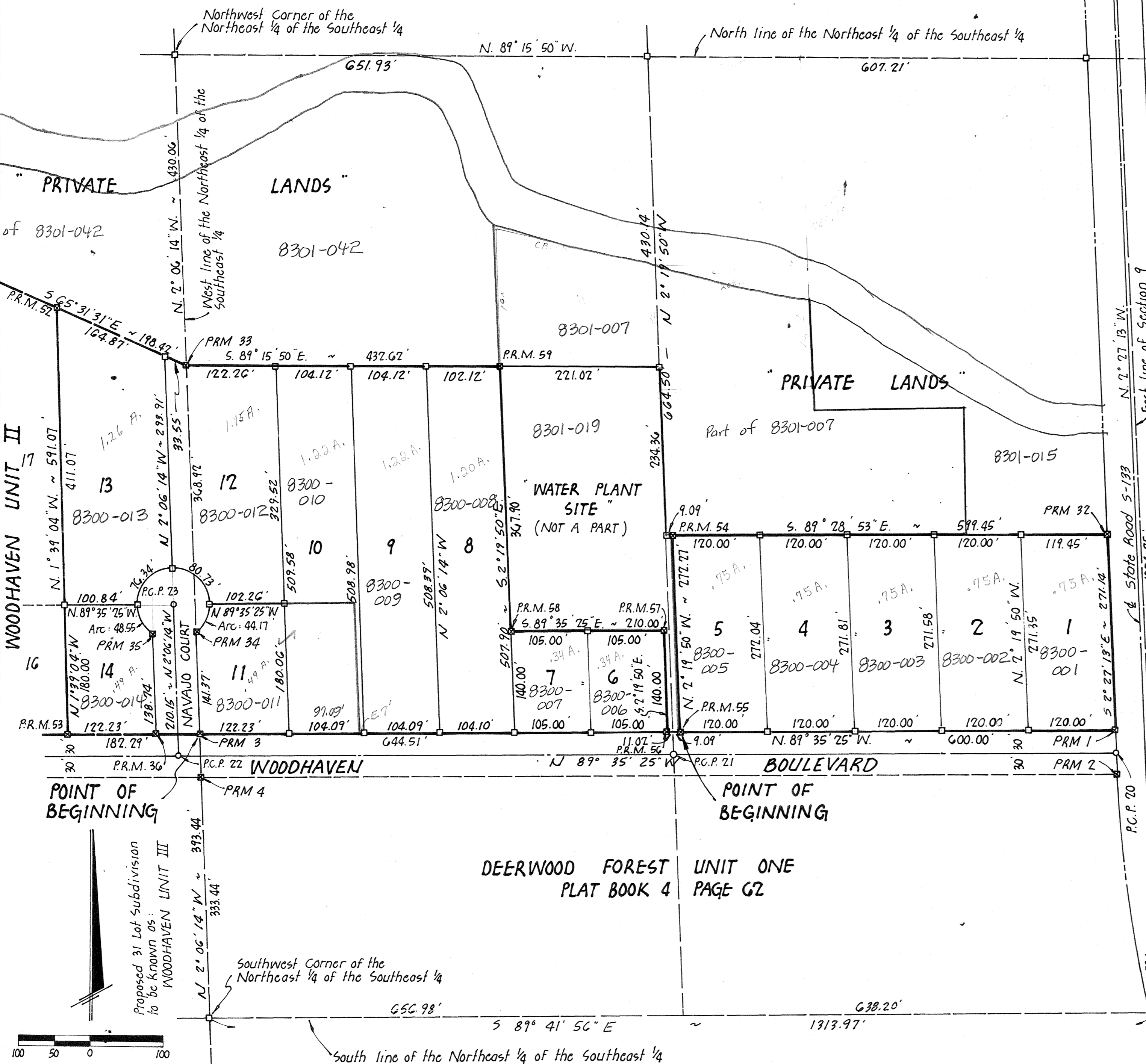

DESCRIPTION:

A TRACT OR PARCEL of land irregular in shape lying partially in the Northwest 1/4 of the Southeast 1/4 and partially in the Northeast 1/4 of the Southeast 1/4, Section 9, Township 4 South, Range 17 East, Columbia County, Florida being more particularly described as follows:
 COMMENCE at the southwest corner of the Northeast 1/4 of the Southeast 1/4, Section 9, Township 4 South, Range 17 East, Columbia County, Florida and run N. 2° 06' 14" W. along the West line of said Northeast 1/4 of the Southeast 1/4, a distance of 393.44 feet to the POINT OF BEGINNING; thence N. 89° 35' 25" W. 182.29 feet; thence N. 1° 39' 04" W. 591.07 feet; thence S. 65° 31' 31" E. 198.42 feet to said West line of the Northeast 1/4 of the Southeast 1/4, Section 9; thence S. 89° 15' 50" E. 432.62 feet; thence S. 2° 19' 50" E. 367.90 feet; thence S. 89° 35' 25" E. 210.00 feet; thence S. 2° 19' 50" E. 140.00 feet; thence N. 89° 35' 25" W. 644.51 feet to the POINT OF BEGINNING. ALSO:
 COMMENCE at the southwest corner of the Northeast 1/4 of the Southeast 1/4, Section 9, Township 4 South, Range 17 East, Columbia County, Florida and run N. 2° 06' 14" W. along the West line of said Northeast 1/4 of the Southeast 1/4 a distance of 393.44 feet; thence S. 89° 35' 25" E. 664.62 feet to the POINT OF BEGINNING; thence N. 2° 19' 50" W. 272.27 feet; thence S. 89° 28' 53" E. 599.45 feet to the West right of way line of State Road No. 5-133; thence S. 2° 27' 13" E. along said West right of way line 271.14 feet; thence N. 89° 35' 25" W. 600.00 feet to the POINT OF BEGINNING.
